*Show Committee 2006:* Kelly Yarish reported the event has been approved by the AKC. Deb Krier will provide labels for the trophy committee immediately. The show chairman was instructed to contact Nancy Roddy regarding hospitality committee.

Advertising – It was decided to not purchase an ad in the Show Beagle Quarterly.

### **Unfinished Business**

*Colorado Beagle Rescue* – Tom Krier will send the donation.

*Club Merchandise* – Deb Krier will accept additional orders. It was suggested an additional \$2.00 be added to each order as a fund-raiser for the club.

*Publicity* – Deb Krier picked up a flyer about a function being held in June, details will be provided next month.

*Membership*– June Suttie reported the board has appointed Rosemary Harris to chair the committee. Existing club materials will be given to Rosemary for review, with the suggestion that she review and present to the club ideas for a new club flyer.

### **New Business**

*Show Chair* – Discussion was held on the 2007 and 2008 events, the board has approved Tom Krier to serve as chairman for both events.

*Judge's Selection* – Deb Krier suggested the consideration for the '08 committee begin immediately. The board will discuss the board representative at their next meeting, and the membership should also select their representative. Tom Krier will also serve as the past show chairman.

*2008 National Specialty* – Deb Krier inquired how the club would like to be kept informed on the '08 NBC event. June Suttie suggested a report be given every other month for the time being, with monthly reports as the event date gets closer. Deb Krier reported she anticipates a final hotel contract soon.

Two NBC members, Eddie Dziuk and Kathy Forbes have made a very generous donation of judging fees to the '08 specialty fund. Deb Krier will get the final souvenir report for the '05 show. Discussion was held on the show secretary for both RMBC and NBC shows. Deb Krier will review the contract of the 2005 show secretary.

*Historian* – June Suttie reported the board discussed establishing this committee to compile a record of the specialty as well as other club functions, club officers, and past meeting minutes. All club members were encouraged to look for items that should be included in the club archives. The board will ask Nancy Roddy to fill this position.

*2007 Judge's Selection Committee* – The 2007 committee, (composed of Liz Friedlander, Teresa Gaier, and Kelly Yarish) suggest the following be adopted for 2007 – the membership is encouraged to submit name's for the '07 specialty, with the deadline for submission May 15<sup>th</sup>. The committee will present the final panel to the membership at the May meeting. Ballots will be sent to the membership by June 1<sup>st</sup>, and all ballots must be returned for tally at the July meeting. Notification to members will be sent both by email and regular mail.

### **Next Meeting**

Our next meeting will be held Thursday, May 18<sup>th</sup> at 7:00 p.m. at the Thornton Civic Center. Deb Krier suggested the July meeting be held in Estes Park to tour the 2008 show site. Details will be discussed next month.
